## Matters of Interest

- 1) On the 1<sup>st</sup> of July 2022 at 5:27 p.m., police received a call from a person who was lost and exhausted with his family at the Mink Mountain Trail system in Neebing Municipality. Police attended and the family was able to walk out to safety with the use of the officer's siren.
- 2) On the 8<sup>th</sup> of August 2022 at 3:53 p.m., police received a call from a Neebing Municipality resident requesting police assist with their intoxicated friend who wanted to drive home. Police attended and after discussing issues of Impaired driving, had a friend attend and drive them home, leaving their vehicle to be picked up the following day.
- 3) On the 7<sup>th</sup> of July 2022 at 02:55 a.m., police received a call from an O'Connor Township resident who reported being followed by a newer red Dodge Ram. The resident took back roads and the vehicle only turned off after seeing a Thunder Bay Police Service vehicle.

Driver found to be impaired by drug, arrested, charged and released. Driver charged with commercial motor vehicle offences related to vehicle.

## **NEEBING MUNICIPALITY**

#### **Violent Crime or Other Criminal Code Violations:**

- 1 Cause Disturbance Complainant reports his neighbour playing loud music all day. Police attend and warn neighbour who was compliant in turning off music.






