# Matters of Interest

- 1) On the 8th of January, 2022 at 1235 p.m., police received report of a Break and Enter at a seasonal residence in Neebing Municipality. Police attended and investigated. Witnesses and evidence determined a group of youths were partying at another nearby seasonal residence and broke into the victim's residence. 4 youths were charged; 2 youths have charges before the courts for 4 counts Possession of Property Obtained by Crime under \$5000, 2 counts of Break and Enter a Dwelling House and commit and Indictable Offence as well as 1 count of Fail to Comply with Sentence. Police recovered most of the victim's property at the nearby residence.
- 2) On the 4<sup>th</sup> of February, 2022 at 12:06 a.m., police received a call from a Conmee Township resident advising unknown persons tried to steal her vehicle from her driveway but drove away after her car alarm went off. Police patrolled area but suspect(s) not located.
- 3) On the 22nd of February, 2022 at 3:52 a.m., police were called to a Conmee Township residence for an unwanted subject who entered a

### **NEEBING MUNICIPALITY**

#### **Violent Crime or Other Criminal Code Violations:**

- 1 Sexual Assault report of sexual assault on child; police investigated, youth charged with Sexual assault and Sexual Interference under the Criminal Code.
- 1 Threats Complainant reports receiving threats on Facebook from former client. Police investigate, no evidence of threats but rude and angry messages.
- 1 Bail Violations Police attend to a vehicle stuck in ditch. Driver found to be unlicenced and on a recognizance not to be driving a motor vehicle. Driver charged for Breaching Recognizance.
- 1 Cybercrime Report of resident who was defrauded \$20,000. Police investigated and had resident contact bank immediately; charges were reversed. Unknown suspect male called complainant trying to set up Anti-fraud system on bank account and accessed personal information. Complainant's financial institution investigating further.
- 1 Prevent Breach of Peace Police receive report that complainant's exspouse threatening to attend property and remove matrimonial property. Police advise both parties to have police present prior to removing property in order to keep the peace. Both parties agreed, no charges laid.
- 1 Possession of Stolen Property Police received call from Pigeon River Border Services of male in custody for Possession of Property Obtained by Crime Over \$5000. Police arrested and charged subject for stolen vehicle.

- 1 Trouble with Youth police called to youth fighting with family. Youth removed and place with Children's Aid Service agency.
- 2 MHA calls police called to Pigeon River Border (CBSA) to assist with male trying to gain entry into USA. Police convinced male to return to Thunder Bay until he has proper documents and vaccination.
- Police called again by Pigeon River Border to assist with same male trying to enter into states. Male in distress with violent ideations to harm himself and others. Police apprehended, subject formed at Thunder Bay hospital.
- 1 Attempt suicide police attend residence where person intentionally overdosed on Fentanyl patches. Ambulance revived and escorted to hospital.

#### Operational:

- 3 Well-being Checks complainant request police check on family member; not answering phone and trying to relay family emergency. Police cancelled while enroute to dispatched address.
- Report of elderly female friend not answering her phone; police determined female in hospital and advised complainant.
- Report of Missing youth police attend residence in Neebing; youth located in city of Thunder Bay
- 1 Sudden Death report of a Sudden Death; police attend. No foul play.
- 2 Neighbour Disputes complainant reports a neighbour staring at her and using foul language when she approached; police advised to avoid contact.
- Complainant reports finding a threatening letter from neighbour as they have made complaints to the Municipality regarding dogs running at large. Reported for police information.
- 2 Assist Thunder Bay Police request to be on lookout for vehicle with two wanted subjects. Patrols made; vehicle not located.
- Thunder Bay Police report missing youth police patrolled known areas you associated with; negative results
- 1 Police Observation Report of Protest at Pigeon River Border and local area. OPP PLT (Provincial Liaison Team) member engaged with protesters. No issues.
- 2 Animal complaints complainant reports animal stuck under tractor. Police assisted in facilitating local resources and veterinarian. Horse removed.

- 2 Community Service calls Elderly female called police to report she was snowed in and cannot receive propane for house. Police attended and engaged nearby contractor to clear driveway in order for Propane delivery to take place.
- OPP PLT member met with Pigeon River CBSA staff to explain role and assistance with recent border protests.
- 1 Police observation Police observe Freedom Protest at Pigeon River Border; no complaints made.
