# Matters of Interest

- On the 19<sup>th</sup> of October, 2021 at 7:47 a.m., police received report of a motor collision between a dump truck and a school bus on Hwy. 608.
   Investigation found driver of dump truck at fault and charge laid under the Highway Traffic Act. The bus driver sustained minor injuries.
- 2) On the 11<sup>th</sup> of November, 2021 at 3:04 p.m., police received report of a Break & Enter at seasonal residence on Cottage Drive East Road. Police canvassed, evidence supported adult male being charged. Same adult charged with 2<sup>nd</sup> Break & Enter on same road after report made on 27<sup>th</sup> of November, 2021 and evidence supported grounds to charge.
- 3) On the 6<sup>th</sup> of December, 2021 at approximately 2:36 p.m., police received a call to assist ambulance with an elderly adult who is failing to cope at home; no heat in home and home not safe for adult. Police attended and convinced male to attend hospital via ambulance. Hospital support provided for adult.
- 4) On the 25<sup>th</sup> of December, 2021 at 10:04 a.m. police received a call from a Conmee Township resident who reported damage to their fence. Police attended, found debris from motor vehicle that went off road, colliding with the fence. Unknown driver failed to report collision.
