### 5. DISCUSSION: NEW BUSINESS RAISED BY MEMBERS; DISCUSSION WITH OPP; ETC.

Member Beitz advised, with respect to scheduling meetings, he will be away from December 28<sup>th</sup> to mid-April. Members present felt a meeting in mid-December could be followed by one in late April to accommodate his schedule.

Chair Holland provided an overview to the members present of the conference that he and Vice Chair Loan had attended in May. 2 specific issues had been discussed in depth over the time frame – firstly, the new Police Services Act legislation, and secondly, the impacts of the pending cannabis legalization. He was approached with respect to being on the Provincial Board. This will await the municipal elections in October. He thanked Staff Sargeant Reppard for recommending that they attend.

More will be forthcoming on the differences between detachment-wide boards and local police service boards. The attendees were advised that responsibility for policing falls on Section 10 boards rather than municipalities.

With respect to the Cannabis legalization, lessons are being learned from Colorado's experience. Calls for service increased and costs to municipalities increased. Discussion was held on other applicable laws – such as zoning by-laws. Provincial sharing of tax revenues with municipalities is not clear. How will the revenue be distributed? Will municipalities without any cannabis businesses within their boundaries get a share at all? Costs will increase, and it is doubtful that revenues will adequately compensate for those increased costs. Law enforcement personnel are concerned, and all are of the opinion that the legalization was "rushed". Some concerns are:

- Repercussions from organized crime for "moving in" on their turf;
- How/when to enforce elements of the law;
- How to test for impairment drawing blood may be required transport the person to hospital? Nurses/doctors have been known to refuse to draw blood if it is not for "medical" purposes.
- Colorado is having problems, as there is no legally acceptable test
- Marijuana has different impacts on different types of people and on different races of people
- Marijuana has different potencies which affect impairment
- Marijuana mixed with alcohol is also problematic
- The medical marijuana industry is experiencing contamination problems (moulds, faeces in product).

On behalf of Neebing Council, the Secretary asked Staff Sargeant Reppard about police "patrols". A discussion ensued about "focused patrols". Tell constituents to report problems (speeding, noise, partying) to the OPP. Where there is a frequency of occurrence, a focus patrol can be established. Inspector Gordon commented that calling in will help the OPP establish analytics of times/places so that police can have a better chance of getting to the right place at the right time.

There being no further business to attend to, Chair Holland adjourned the meeting at 7:55 p.m.
