Matters of Interest	<p>Increased calls for service to Pigeon River border Crossing. Suspicious activity noted where individuals loitering at the border crossing and photographing employees and the crossing itself.</p> <p>27 RIDE checks were conducted within the confines of the Lakehead Police Service Board are.
