Matters of Interest

- 1) On the 25th of March, 2020 at approximately 11:50 pm officers were dispatched to attend a residence in O'Connor Township for an unwanted male. The 25 year old intoxicated male subject was attempting to gain access to the residence through the garage. He broke several items inside the garage and threatened the three occupants inside the house with a broken wine bottle. The male was arrested by officers and charged criminally with Mischief, Utter Threats, and drive over 80.
- 2) There were approximately 26 vehicles checked as a result of 6 R.I.D.E.'s conducted for the months of January, February and March 2020. Highway Traffic Act tickets and warnings were issued as a result of R.I.D.E.
- 3) On the 3rd of February 2020 at 4:00 pm Canada Customs at Pigeon River Border crossing requested OPP officers for a male who was under arrest for impaired operation by drugs. The male was transported to Thunder Bay OPP detachment and completed a DRE examination. As a result of the examination, visual observation and the information provided by the involved border officer the male was charged with impaired operation of a motor vehicle by drugs.

- 1 property related incident where old ammunition was turned over for disposal.
- 3 motor vehicle collisions. 2 involving vehicles losing control on icy snow packed roadways. Third MVC involving an inattentive driver hitting another vehicle while making a left hand turn.
- 2 fire incidents reported. One involving a chimney fire at a residence and the second involving a vehicle on fire.
- Three 911/hang up calls. Two involving cellular misdials. The third involving a complainant requesting assistance for an elderly female who fell down.
- 1 traffic enforcement incident where a female driver was issued a 3 day suspension as a result of a warn on the roadside device.
- 1 escort incident where a female was escorted to the Pigeon Border crossing.
- 1 other criminal code call involving the possible theft of a dog.
- 4 family dispute incidents. Two involving disputes between fathers and sons. One involving CAS and questionable parenting. The fourth involving a possible suicidal mother.
- 1 mental health call where a 57 year old female was apprehended and transported to the hospital for assessment.
- 1 abandoned vehicle incident where a truck ran out of gas and was later removed by the owner.
- 2 impaired/ over 80 incidents.
- 2 animal complaints. One involving dogs at large. The second involving the report of a dead horse which was unfounded. The owner advised a pregnant horse was lying down.
- 3 property check incidents. One incident checking on the municipal office. Two involving patrols at Old Border Rd.
- 2 domestic disputes. One in regards to an ex-husband not storing firearms properly. The second involving child custody issues between a separated

husband and wife.

- 1 ambulance assist call where a female appeared to suffer a stroke.
- 1 threat incident involving an argument between intoxicated neighbors.
- 1 traffic complaint in regards to a possible impaired male driver.
- 1 false alarm calls which was cancelled prior to officer's arrival.

O'CONNOR

- 1 traffic enforcement incident where a male driver was stopped and charged for speeding and suspended driving.
- 3 traffic complaint incidents. One involving snowmobiles trespassing on private property. The second involving reports of an unlicensed driver possible intoxicated. The third involving a near miss collision involving a loaded log truck.
- 2 family dispute calls. One where a brother was reporting that his sister was breaching a Peace Bond condition. The second where a 22 year old daughter was having a fit and throwing stuff inside a residence.
- 1 single motor vehicle collision where a female having a diabetic episode drove into a snowbank.
- 1 assault incident where a teenage son assaulted his father.
- 1 sudden death incident involving a 64 year old female who had a history of cardiac issues.
- 1 mischief incident where a daughter was throwing things inside a residence breaking property.

- 1 domestic dispute involving unwanted texting and children custody issues.
- 2 motor vehicle collisions. One involving a vehicle hitting a snowbank. The second involving a vehicle losing control and side swiping another vehicle on a curve.
- Two 911/ hang up calls which were both cellular misdials.
- 1 attempt or threat of suicide call where a female took a number of pills.
- 1 assist ambulance call where a heavily intoxicated female was transported to hospital by ambulance.
- 1 assault incident where a male was arrested for domestic assault.
- 1 false alarm call. The alarm was cancelled prior to officer's arrival.
- 1 firearms related incident where a male was arrested and charged criminally.

GILLIES

- 3 trouble with youth incident at a public school due to a 12 year old being bullied.
- 2 mental health calls. One involving a 16 year old son who was acting violently. The second involving an elderly husband and wife with a history of dementia.
- 2 person well-being check incidents. Both incidents found the person in good health.
