



Notice of a Public Meeting being held to consider an application for a proposed Land Severance
(Application Numbers B05-2026)

Please take notice that the Council of the Corporation of the Municipality of Neebing, sitting as Committee of the Whole, will hold a Public Meeting on Wednesday, June 3, 2026, at 5:30 p.m., at the Neebing Municipal Office to consider a proposed severance under Section 53 of the Planning Act, R.S.O. 1990, c. P.13, as amended. The Committee's recommendations to Council will be considered for ratification at the Regular Council Meeting on the same evening, commencing at 6:00 p.m.

The Application (B05-2026) is brought by John and Alison Dryden, the property owners. The land parcel which is the subject matter of the application is a residential property with municipal address 715 Wamsley Road. The legal description of the land is: Concession 3 South Part Section 17, Parcel 5616, within geographic Pearson Township, Municipality of Neebing, in the District of Thunder Bay. This is referred to as the "Subject Property".

The purpose of the proposed severance is to create three new lots plus the retained lot. The severed parcels will each be rectangle in shape with 100 m of frontage on Wamsley Road and will be 400 m in depth. A sketch showing the lot configuration is included with the application, a copy of which is available on the Neebing website (www.neebing.org/notices) or by contacting the Municipal Office. All measurements are "approximate", and will be finalized when the required survey has been completed.

If a person or public body has the ability to appeal the decision of the Municipality of Neebing in respect of the proposed consent to the Ontario Land Tribunal but does not make written submissions to the Municipality of Neebing before it gives or refuses to give a provisional consent, the Tribunal may dismiss the appeal.

How to provide input: You can provide input on the application as follows:

- a) Submit comments in writing by email, to clerk@neebing.org;
- b) Submit comments by regular mail to the mailing address below; or
- c) Attend the public meeting in-person, or via electronic means, and register with the Clerk-Treasurer, upon arrival, indicating your wish to address the Public Meeting orally.

A computer or video sharing device is not required to participate in the electronic meeting. You may also opt to call in from a cell phone or landline.

Please note that, in order to be considered, written comments must be submitted by 4:30 p.m. on Wednesday, June 3, 2026. It is the writer's responsibility to check with the Clerk-Treasurer, using the contact information below, to confirm that electronically submitted or mailed written comments have been received.

If you wish to be notified of the decision of the Municipality of Neebing in respect of the proposed consent, you must make a written request to the Clerk-Treasurer at the address below.

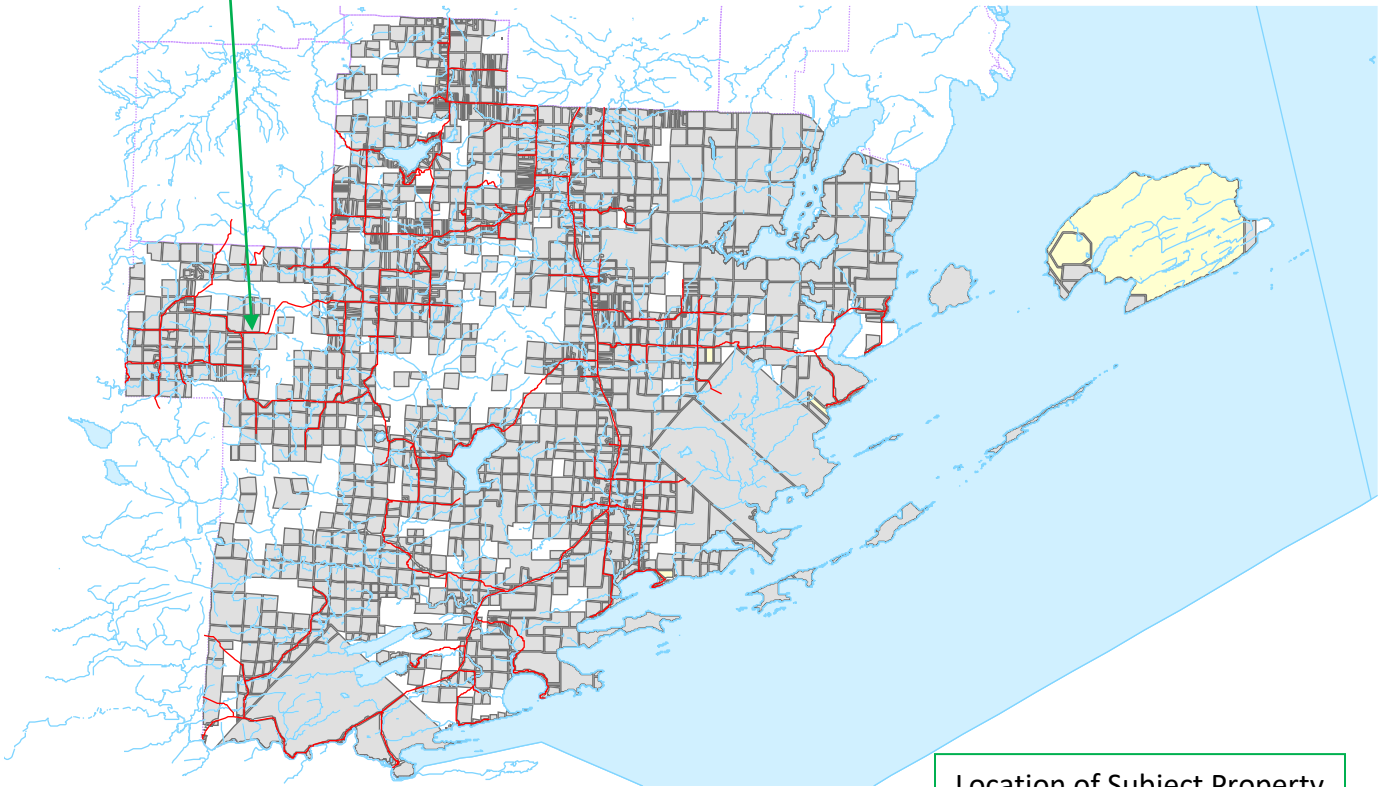
