



**Notice of a Public Meeting being held to consider an application for a proposed Land Severance
(Application Numbers B01-2026)**

Please take notice that the Council of the Corporation of the Municipality of Needing, sitting as Committee of the Whole, will hold a Public Meeting on Wednesday, February 4, 2026, at 5:45 p.m., at the Needing Municipal Office to consider a proposed severance under Section 53 of the Planning Act, R.S.O. 1990, c. P.13, as amended. The Committee's recommendations to Council will be considered for ratification at the Regular Council Meeting on the same evening, commencing at 6:00 p.m.

The Application (B01-2026) is brought by Ryan Berringer and Jamie Foster, the property owners. The land parcel which is the subject matter of the application is vacant land with no municipal address on Memory Road. The legal description of the land is: Part Mining Location 5A, Part 4 on Reference Plan 55R11914, within geographic Crooks Township, Municipality of Needing, in the District of Thunder Bay. This is referred to as the "Subject Property".

The purpose of the proposed severance is to create four new lots plus the retained lot. The severed parcels will be rectangle in shape and will have frontage on Memory Road. A sketch showing the lot configuration is included with the application, a copy of which is available on the Needing website (www.needing.org/notices) or by contacting the Municipal Office.

If a person or public body has the ability to appeal the decision of the Municipality of Needing in respect of the proposed consent to the Ontario Land Tribunal but does not make written submissions to the Municipality of Needing before it gives or refuses to give a provisional consent, the Tribunal may dismiss the appeal.

How to provide input: You can provide input on the application as follows:

- a) Submit comments in writing by email, to clerk@needing.org;
- b) Submit comments by regular mail to the mailing address below; or
- c) Attend the public meeting in-person, or via electronic means, and register with the Clerk-Treasurer, upon arrival, indicating your wish to address the Public Meeting orally.

A computer or video sharing device is not required to participate in the electronic meeting. You may also opt to call in from a cell phone or landline.

Please note that, in order to be considered, written comments must be submitted by 4:30 p.m. on Wednesday, February 4, 2026. It is the writer's responsibility to check with the Clerk-Treasurer, using the contact information below, to confirm that electronically submitted or mailed written comments have been received.

If you wish to be notified of the decision of the Municipality of Neebing in respect of the proposed consent, you must make a written request to the Clerk-Treasurer at the address below.


